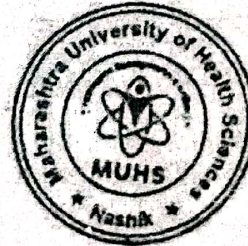

- The Government of Maharashtra owns & manages 300 bedded hospital at Osmanabad since 01.07.1923
- It is desirable to establish a Medical College in the public interest;
- Establishment of a Medical College with 100 (Hundred) admission capacity MBBS course at Osmanabad is feasible.
- Adequate clinical material as per the National Medical Commission norms is made available by the institution.

It is further certified that in case, the Government of Maharashtra fails to create infrastructure for the medical college, as per NMC norms and fresh admissions are stopped by the Central Government, the State Government shall take over the responsibility of the students already admitted in the College with the permission of the Central Government/National Medical Commission.
