MBBS Admission Instructions – Academic Year 2025-26

Hostel Facility:

Hostel accommodation is available for both Boys & Girls for the academic year 2025-26.

Instructions for Students Before Coming for MBBS Admission:

1] Document Verification:

The verification process is time-consuming. Please ensure you report to the institute on time as per the schedule provided.

2] Read Instructions Carefully:

Students must read this instruction manual completely before arriving for the admission process.

3] Admission Form:

Students must bring the pre-filled, downloaded Admission Form (available on the college website). Fill in CAPITAL LETTERS using a Blue Pen only.

4] Soft Copies of Documents:

Bring soft copies of all required documents in a separate Pen Drive. Each document must be in PDF format and less than 300KB in size.

5] Annexure-C Form:

Bring the pre-filled Annexure-C Form at the time of admission. (Refer Page No. 9 of the instruction booklet)

6] Caste Certificate Validation:

Carefully cross-check your Caste Certificate, Caste Validity, Name, Number, and Issuing Date – all must match.

7] All India Category Students:

(OBC-NCL, SC, ST candidates not domiciled in Maharashtra) must bring Caste Validity Certificate in the format of ANNEXURE–III. (Refer Page No. 16)

8] Nationality/Nativity Certificate (for Non-Maharashtra Students):

Ensure your Leaving Certificate mentions your Nationality/Nativity as Indian. If not, bring a Nationality/Nativity Certificate signed by a Magistrate/Tehsildar. (As per format on Page No. 14)

9] Medical Certificate:

Must be in the format of ANNEXURE-H. Refer to NEET Brochure (Page No. 31, 32)

10] Demand Drafts (D.D.) – Submission Instructions:

Soft copy of all three D.D.s must be on a single page and saved as one PDF file (size <300KB).

Mention: Candidate's Name, AIR, Mobile No., and Category on the back side of each D.D.

Bring two Xerox copies of all three D.D.s.



17. CONDUCT AND DISCIPLINE:

- 17.1 Failure of the candidate in making full and correct statements in the application form and/or suppression of any information would lead to disqualification of the candidate, even at later date. Such a candidate will be debarred from the entire selection process.
- 17.2 It is responsibility of every candidate to submit proper documents. Any attempt to submit documents which are not genuine will lead to cancellation of the admission of the candidate, forfeiture of the fees, deposits and expulsion of the candidate from the college by the Competent Authority or by his authorised official. The name of such candidate/s shall be deleted from the State Merit List and he/she will not be eligible for further rounds of the selection process and will be debarred from the selection process. If deemed fit even criminal proceeding may be initiated by the Competent Authority against such candidates / their parents. If any candidate I authorised representative or person accompanying is found obstructing the counseling and I or admission process, or trying to influence in unlawful manner/ creating nuisance, the candidate shall be liable for disqualification from the process of selection and appropriate legal action will be taken. The decision taken by the Competent Authority in this respect shall be final and binding.
- 17.3 The student while studying in the Health Sciences Courses, if found indulging in antinational activities, unlawful activities or ragging in any form, contrary to the provisions of relevant Acts and Law enforced by Government, will be liable to be expelled from the college by the Dean/Principal of the College.
- 17.4 Pursuant to orders in W.P. (Civil) No. 656 of 1999, Hon'ble Supreme Court of India, has directed the Department of Human resources Development and Education, Govt. of India, to take all necessary steps to curb the menace of ragging and take severe action against the students involved in such activities.
- 17.5 As per the provisions of Maharashtra Act XXXIII known as "Maharashtra Prohibition of ragging Act of 1999", students indulging in ragging can be punished under the Act resulting in suspension, expulsion from the college and imprisonment.
- 17.6 Any issue not dealt here in above will be dealt with when arising, fully and finally by the competent Authority. Any amendment made by Government of India / Government of Maharashtra / Hon'ble courts from time to time will be implemented.
