- 1) This Continuation / Extension of affiliation is issued for the A.Y. 2024-2025 subject to the permission of National Medical Commission, New Delhi and / or Government of India and if the permission is declined by the said authorities this Continuation / Extension of Affiliation shall be treated as cancelled. The College is not authorized to admit the students for 1st Year of the course until receipt of permission of the National Medical Commission, New Delhi and / or Government of India.
